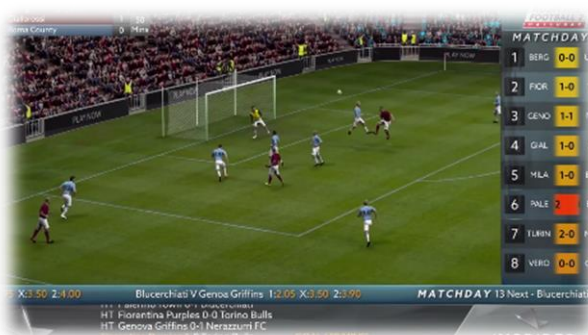




LT GAME AND INSPIRED GAMING (UK) SIGN EXCLUSIVE AGREEMENT TO PROVIDE VIRTUAL SPORTS ON ELECTRONIC TABLE GAME TERMINAL IN MACAU

Hong Kong – October 4, 2016 – Paradise Entertainment Limited (SEHK: 1180) ("Paradise" or "the Company") announced that its subsidiary LT Game Limited ("LT Game"), a Macau's leading electronic gaming solutions provider, has signed an exclusive agreement with Inspired Gaming (UK) Limited ("Inspired"), the leading provider of Virtual Sports, Mobile Games, Server-Based Gaming system and Video Lottery, whereby Inspired will offer Virtual Sports on LT Game's Electronic Table Game ("ETG") terminals in Macau and LT Game will become the exclusive distributor of Inspired's Virtual Sports in Macau.
