**Announces the Launch of LIVE Baccarat in  
Lisboa - Monalisa Casino and Jai Alai Casino of SJM  
Number of LIVE Baccarat terminals will surge to 300 by the End of 2006**

(Hong Kong, 9 November 2006) – **LifeTec Group Limited** (“LifeTec” or “the Group”) (SEHK: 1180) today announces that LT Game Limited, its wholly-owned subsidiary, entered into supplementary agreements with Sociedade de Jogos de Macau S.A. (“SJM”) on 8 November 2006, to install LIVE Baccarat system (the “LIVE Baccarat”) with 120 and 100 LIVE Baccarat terminals in SJM’s managed Lisboa – Monalisa Casino (“Monalisa”) in Hotel Lisboa and Jai Alai Casino (“Jai Alai”), following the agreement signed with SJM on 29 April 2006. The Group plans to commence the operation of LIVE Baccarat in the two aforementioned casinos before the end of November 2006 and before the end of 2006 respectively. Consequently, the total number of LIVE Baccarat terminals in operation in Macau will surge to 300 by the end of 2006.

The Group is pleased to enter into these supplementary agreements with SJM to install the LIVE Baccarat terminals in its flagship Lisboa and Jai Alai Casinos, in particular, the whole third floor of Monalisa will be used exclusively by the Group for LIVE Baccarat gaming. The collaboration reflects an endorsement of the potential of LIVE Baccarat business by SJM. Casino Lisboa is the landmark of Macau and it attracts an enormous number of tourists and gamblers from mainland China and all around the world. By establishing a mega LIVE Baccarat gaming hall in Lisboa Casino, the Group can greatly enhance the publicity of LIVE Baccarat.

LT Game Limited signed a 5-year collaboration agreement with SJM on 29 April 2006 to introduce the LIVE Baccarat in SJM’s casinos in phases from 30 April 2006. The Group receives 31% of the pretax net win generated by LIVE Baccarat. By the time the agreement expires, both parties will renegotiate the terms of collaboration according to the latest operating circumstances. As at the end of October 2006, the Group installed 40 LIVE Baccarat terminals each in New Century Hotel Greek Mythology Casino and Diamond Casino at Holiday Inn Macau. A total of 80 LIVE Baccarat terminals are operating in Macau.

**About LifeTec Group Limited (SEHK: 1180)**

LifeTec Group Limited is a Hong Kong listed company (SEHK: 1180) which has two major divisions run by wholly-owned subsidiaries LifeTec Pharmaceutical Limited (“LifeTec Pharmaceutical”) and LT Capital Limited (“LT Capital”).

LifeTec Pharmaceutical develops, distributes and sells biopharmaceutical products.

LT Capital is the corporate investment arm of the Group. It focuses on investment projects in the fast-growing business sectors. LIVE Baccarat is one of the major projects of LT Capital. This electronic gaming system is being installed in a number of Macau casinos on an income sharing basis.
